Dear President Durkee:

Greetings in the name of our Lord Jesus Christ. This letter is your official notification of ABHE Commission on Accreditation actions relative to Penn View Bible Institute.

The ABHE Commission on Accreditation reviewed your institution at its February 12-16, 2022, meeting and took the following action:

**Reaffirm the accreditation of Penn View Bible Institute (PA) until 2032 in light of the Commission on Accreditation’s judgment that the institution substantially complies with ABHE’s Institutional Accreditation Standards, including documentation of the appropriateness, rigor, and achievement of its stated student learning outcomes and all other Title IV eligibility requirements.**

The Commission also reviewed 2021 Annual Report indicators for institutions with data outside margins specified in the Policy and Procedures for Monitoring Annual Report Data. **Please provide a one-page explanation for the data exception noted below by May 15, 2022.** If the issue being raised is the result of a data error or a one-year anomaly, the explanation is all that is needed. If subsequent action is needed, the Commission may ask for a follow-up report.

**Faculty Qualifications:** Fewer than 80% of Fall 2021 student credit hours taught by faculty holding a master’s degree (undergraduate) or doctoral degree (graduate). Data reported are as follows:
